ADDITIONAL CONDITIONS:

INSPECTION AND CLAIMS: The Buyers shall have the right to apply to competent Authority for inspection after discharge of the goods at destination port. Should the quality and/or quantity/weight be found not in conformity with invoice or quality certificate, the Buyers shall be entitled to lodge claims against the Sellers on the basis of their surveyreport within 15 days after discharge of the goods at the destination port. However, of those claim for which the shipping company/or insurance company are to be held responsible.

FORCE MAJEURE: In case of Force Majeure such as war, serious fire, flood, typhoon and earthquake or other events agreed by both parties, which might occur during the process of manufacturing or in the course of loading or transit, the Seller shall not be held responsible for delay in delivery or non-delivery of the goods but shall notify immediately the Buyer by fax within fourteen days thereafter and deliver to the Buyer by registered mail a certificate issued by government authorities or chamber of commerce as evidence. Under such circumstances, the Seller, however, is still under the obligation to take all necessary measures to expedite the delivery of the goods.

ARBITRATION: All disputes arising from the execution of or in connection with this contract shall be settled through friendly consultations. In case no settlement can be reached, the case in dispute shall then be submitted to the Foreign Trade Arbitration Commission of the China Council for the Promotion of International Trade for Arbitration in accordance with its Provisional Rules of Procedure. The decesion made by this commission shall be regarded as final and binding upon both parties. Arbitration fees shall be borne by the losing party, unless otherwise awarded.

GOVEMING LAW OF THE CONTRACT: United Nations Convention on Contracts for the International Sale of Goods.
